| | The cutting of the Common too often rather than letting flowers seed the resident felt that it should only be cut once at the end of the season <i>Cllr Edge felt that the resident had given some worthwhile comments.</i> <i>The Chairman asked whether this was just in regards to Hazel Moor? And</i> <i>added that the Common land was cut twice a month at the moment.</i> <i>Cllr Wood made a comment In regards to the Middle Green that if it was</i> <i>not cut there could be complaints. Cllr Howells Lower Green – no problem</i> <i>with it cut less frequently but reminded the meeting that when wild plants</i> <i>were left to grow Hymalyan balsam (invasive species) could be one of</i> <i>them. Cllr Henderson felt that residents should be asked their opinion –</i> <i>cut or left? And Cllr Bibby felt that it would be better for the Committee</i> <i>to decide what it wanted and provide the reason for that decision.</i> <i>Cllr Edge added that the boggy land on the Lower Green was being</i> <i>chewed up by the machinery and damaging the soil structure;</i> <i>There was an awareness that all members of the Committee were not</i> <i>present and the Chairman felt that everyone should think about views</i> <i>and proposals and bring to the next meeting where a vote would be</i> <i>taken.</i> New roads on Common land Parking sign at Park Gate – the Chairman was aware of this and had <i>replied to the resident</i> | |
